

Did you receive an invitation for the Virtual Town Hall for 85 Holton Ave S?

You may have recently received a flyer regarding the proposed development at 85 Holton Avenue South from United Property Resource Corporation (UPRC). The 85 Holton Ave "Site" is home to the historic St. Giles Church and **not an empty lot**.

Built in 1912-13 St. Giles was maintained for over a century by community fundraising and bequests. The metal roof was replaced in 2001.

St. Giles is the only church designed new by architects Stewart & Witton. If designated this would be the first Heritage property in Gibson below Barton St. and only the third in the Gibson Neighborhood.

A major work of architecture and an ACO (Architecture Conservatory of Ontario) Building at Risk, St. Giles is nominated to the 2021 National Trust for Canada Endangered Places list.

The original St. Giles church should be adapted for reuse and included in this development.

Adaptive reuse is greener & cheaper than a new build.

\$1 million - repairs needed in 2018

\$2 million - estimated cost to demolish

June 2018: City of Hamilton Municipal Heritage Committee recommend emergency heritage designation, finding St. Giles meets 8/9 criteria (PED18153) - **Only 1 is needed**

April 2021: Planning Committee again recommends emergency heritage designation
